SALE CONDITIONS

- The Haras de Malleret proposes a "live foal guarantee" which means that after making an advance payment, the rest of the order is to pay 48 hours after the birth of the foal.
- The breeder buys a servicing card of our stallion Fantom de Malleret, for insemination purposes with frozen semen, under the following terms:
 - ➤ A deposit of 604,90€ incl. tax has to be paid when ordering semen and including:
 - 380€ excl. tax (VAT at 5,5%) on the total amount of the mating 950€ excl. tax,
 - Technical fees: 70€ excl. tax (VAT at 20%).
 - Transport fees: 100€ excl. tax for France (VAT at 20%), prices for European or worldwide shipment on demand
 - ➤ The remaining 601,35€ incl. tax (VAT at 5,5%* = 570€ excl. tax) has to be paid 48 hours after the foal's birth. The servicing card will be issued once the total amount is received by bank transfer (950€ excl. tax)
 - * On condition that the VAT rate is not changed.
- If the mare is not full on 31* October of the year of order (confirmed by a veterinary certificate), the servicing card will be transferred to the following year, only the transport and technical fees have to be paid again except if you straws left over from the previous year.
- The stallion is currently part of studbook 2 and will finish his approval tests in 2023 in order to move into studbook 1.
- Technical and transportation fees are not refundable or postponed.
- Any delay in payment will lead to the billing of default interest at a legal rate.

INSEMINATION CONDITIONS

- Purchaser declares to have taken notice of the conditions in which take place the inseminations. He will, indeed, make with the insemination center a distinct accommodation agreement for his mare and the seller would not be considered responsible for any harm that could occur to the purchaser's mare in the facility.
- The positioning and accommodation charges, the gynecological follow up and eventual analysis costs remain at the buyer's charge.
- Every sale contract includes 2 doses of 6 straws of frozen semen.
- Unused doses remain the property of the seller. The buyer agrees to send back to the seller any unused frozen semen.
- The semen can't be transmitted to a third person. The doses will be used only on this particular mare.
- If the purchaser uses the frozen semen without authorization, he will be imposed, without exception, a fine of 2500€ in addition to all outstanding receivables.
- The frozen semen may only be used for conventional artificial insemination or for embryo transfer. The use of the semen for ICSI or other advanced breeding technics is only permitted after prior agreement.
- The frozen semen will be invoiced for each mare and contains a maximum of 2 doses of insemination material.
