

Sale Contract

Special Terms and conditions for the sale of horses

The present contract represents the special terms and conditions for the sale of horses between the seller and the buyer designated hereafter, and is in addition to the Terms and Conditions of Sale of Haras de Malleret, with which the buyer has become familiar. This document is governed by the provisions of articles L.213-1 et al of the Rural Code.

For the purchase of any horse by an amateur rider, it is reminded that a horse is an animal which, depending on the intended purpose, must necessarily be trained and monitored by persons having the necessary skills (professional rider, and teacher). This requirement is all the more important when the animal purchased is young and at the end of being broken.

It is expressly agreed that, in case of failure to make even a single payment, and beyond a period of 8 days following formal notice to pay the balance, sent to the buyer, the present sale shall be cancelled and the horse sold will be brought back to the seller or to the place which the seller has indicated, at the expense of the buyer. The payments made will be retained by the seller as an indemnity for termination of the sale.

In any event, the registration certificate of the horse will only be remitted to the buyer after the price has been paid in full (article R 215-4 of the Rural Code).

Delivery of the horse:

Delivery is completed on this day and under the responsibility of the buyer.

The pick-up is scheduled for:

In all cases, the transfer of ownership takes place from the time of signature of the present document, and the buyer assumes ownership for the expenses and risks for the horse starting from this day. The buyer declares to be insured for civil liability.

In case of late pick-up, the buyer will owe the seller the sum of 28€ vat not included per day on straw, 32€ per day on shavings starting from Monday September 25th, 2017.
